**ESTABLISHING RIGHTS-OF-WAY CONSTRUCTION STANDARDS**

Section 1(4) That all traffic signs and signs of any type shall be consolidated so there are an absolute minimum amount of posts or poles. Whenever possible, signs will be placed on existing electric or telephone utility poles.
