RE: Finance Report for March, 2014

The UAN report has been included in your packet. Some of the highlights from the General Fund have been summarized and described below:

General Fund Revenue

Earnings Tax

Earnings Tax collections for the month of March totaled \$142,926. This is up 145% from March 2013’s collection of \$58,298 and up 14% compared to year-to-date in 2013. Earnings tax continues to be the Village’s primary revenue source. This chart shows how the earnings tax has tracked since 2006. The estimate for 2014 is \$2,500,000.



Property Tax The Village did not receive any property tax revenue during March. These monies are released by the County Auditor’s Office in April.

Local Government Fund

The Local Government Fund has netted \$1,954 for March. The graph highlights the LGF Revenue for the years 2006- March 2014. The projection for 2014 is \$52,605.

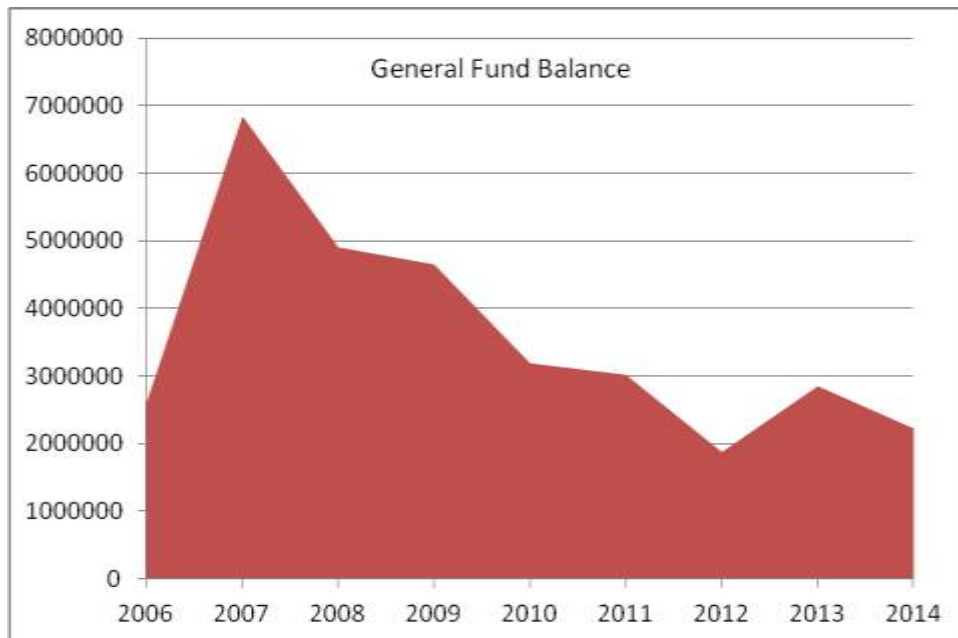
