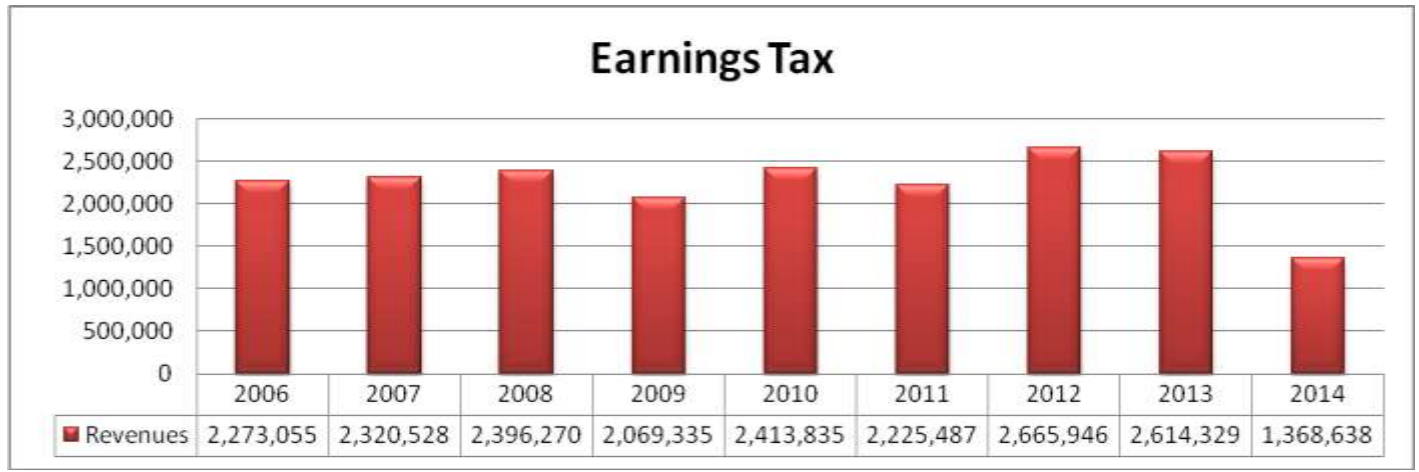
RE: Finance Report for April, 2014

The UAN report has been included in your packet. Some of the highlights from the General Fund have been summarized and described below:

General Fund Revenue

Earnings Tax

Earnings Tax collections for the month of April totaled \$726,316. This is down 2.6% from April 2013’s collection of \$745,116 and up 4.6% compared to year-to-date in 2013. Earnings tax continues to be the Village’s primary revenue source. This chart shows how the earnings tax has tracked since 2006. The estimate for 2014 is \$2,500,000.



Property Tax The Village collected \$505,414 of real estate and property taxes as well as \$4,233 in inheritance tax revenue during April.

Local Government Fund

The Local Government Fund has netted \$4,206 for April. The graph highlights the LGF Revenue for the years 2006- April 2014. The projection for 2014 is \$52,605.

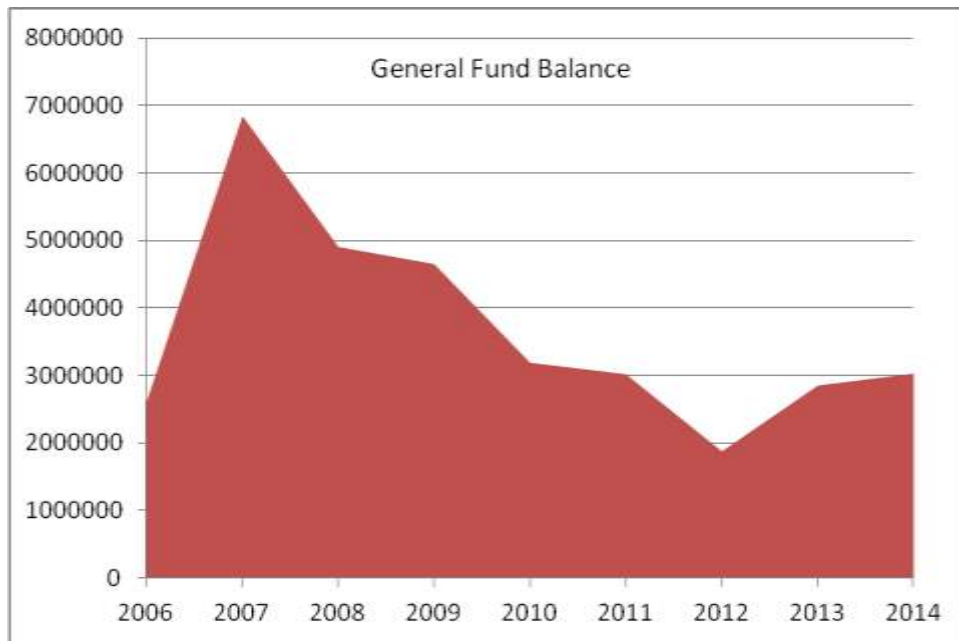
