RESOLUTION AUTHORIZING THE VILLAGE MANAGER TO AWARD A CONTRACT TO RUMPKE OF OHIO, INC., FOR FURNISHING SOLID WASTE REMOVAL AND RECYCLING COLLECTION AND DISPOSAL FOR THE VILLAGE

WHEREAS, the Village Manager having prepared specifications for, and having advertised for, waste removal and recycling collection and disposal for the Village, and having received only a bid form, Rumpke of Ohio, Inc., which is the current provider for such services to the Village, and

WHEREAS, the specifications required a bidder to provide quotes for the costs to be charged for one, three, or five year terms, with provisions for extensions, and

WHEREAS, Council's Education, Health and Welfare Committee, and the Village Manager, each having reviewed the specifications and the bid of Rumpke of Ohio, Inc., and each having recommended to Council the acceptance of said bid for a three year term, with the option of a one year extension,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF AMBERLEY VILLAGE, STATE OF OHIO, six (6) members elected thereto concurring:

SECTION 1: That the bid of Rumpke of Ohio, Inc., of Hamilton County, Ohio, received in response to the public advertisements requesting proposals for furnishing solid waste removal and recycling collection, be, and hereby is, accepted; the contract with Rumpke of Ohio, Inc., to be for a three year term commencing January 1, 2010, which, at the Village's option, may be extended for one year.

SECTION 2: That the terms, provisions and conditions of the specifications and bid referred to herein be, and hereby are, by reference incorporated herein, and shall be a part of the contract with Rumpke of Ohio, Inc.

SECTION 3: That Rumpke of Ohio, Inc., during the term of the contract, and any extension, will provide a mailer to residents offering to provide to them a 65 gallon waste and/or recycling cart, at the resident's cost of \$65.00. An interested resident would contact Rumpke to arrange for the purchase and delivery, and would pay the cost directly to Rumpke of Ohio, Inc.

SECTION 4: That the Village Manager be, and hereby is, authorized and directed to enter into a contract on behalf of the Village with Rumpke of Ohio, Inc., for the collection and disposal of solid waste and recyclable materials in accordance with the specifications and bid, a copy of said contract being attached hereto, and by reference incorporated herein.

SECTION 5: That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
